

**Agreement about partnership
between Polytechnic college of State higher educational institution "Kryvyi Rih National University" (Ukraine) and University of Zilina (Slovakia)**

State higher educational institution "Kryvyi Rih National University" represented by the rector Stupnik Mikola Ivanovich, existing on the basis of the Statute, Polytechnic college of State higher educational institution "Kryvyi Rih National University" as a separate structural unit represented by the director Kulishova Natalia Oleksiivna, existing on the basis of power of attorney 30.11.2016 №44 on the one hand and University of Zilina represented by TATIANA ČOREJONÁ existing on the basis of _____ on the other hand have agreed as follows:

Article 1

The subject of the Agreement is a partnership in the sphere of education and science, an assistance for an effective functioning of higher and graduated professional education, a preparation of scientific articles and materials, an increase of workers' qualification, an integration of professional education and science.

Article 2

The both partners according to the equal rights and mutual interests will develop the following forms of partnership:

- an invitation of representatives of educational staff for making lectures and consultations;
- an exchange of students for passing educational and predegree practice;
- a realization of collective scientific research and educational projects;
- a holding of scientific conferences;
- an exchange of educational-methodical materials and scientific-technical information;
- an organization of scientific, educational and cultural events;
- collective publications.

Article 3

Financial and other conditions of working on the basis of this agreement are installed by separate agreements or individual written invitations which are sent by partners to each other.

Article 4

This agreement doesn't exclude other forms of partnership which can be proposed to every partner. All changes in the Agreement are made in the written form and are signed by the both partners.

Article 5

This Agreement takes effect since the moment of signing by representatives of both sides and is unlimited.

Each partner has a right to interrupt this Agreement sending a written announcement not later than 6 months before the finishing the relations. In the case of interrupting of this acting Agreement, other agreements which are signed by the partners under its implementation, continue their effect according to the conditions and timing.

Article 6

Existing on the basis of this Agreement partners will follow to the legal system of Ukraine and Slovakia.

Conflicts about this Agreement will be decided by making discussions between partners.

This Agreement is signed in triplicate in English, Ukrainian and Russian languages which have equal legal meaning.

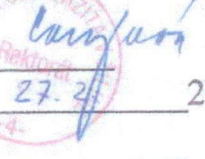
